**AFFIDAVIT AND NOTICE TO REQUIRE A FORENSIC AUDIT**  
***To Ensure the validity of the 2020 Election Cycle, et al.***

I, \_\_\_\_\_, a \_\_\_\_\_, am over the age of consent, and am one of WE THE PEOPLE, living on the land known as Utah State; and as referenced in the Utah Constitution, Preamble.....

*“Grateful to Almighty God for life and liberty, we, the people of Utah, in order to secure and perpetuate the principles of free government, do ordain and establish this CONSTITUTION.”*

As such, We The People bring the following claims and facts that you and your agents may provide due careful consideration:

Take notice that in our Utah State Constitution, which you have sworn an oath to, explains that the People have the right to regulate their internal government, and therefore, and when the public welfare may require, there is a guaranteed right to alter or reform their government. [Utah Constitution, Article I, Section 2]

By this Affidavit, this serves as notice that I require a forensic audit of the 2020 election cycle to ensure the validity of our elections and the strength of our Constitutional Republic. (See Constitutional provision below:)

**UTAH CONSTITUTION, BILL OF RIGHTS, ARTICLE I, SECTION 2**  
**[All political power inherent in the people.]**

*All political power is inherent in the people; and all free governments are founded on their authority for their equal protection and benefit, and they have the **right to alter or reform** their government as **the public welfare may require**.*

**UTAH CONSTITUTION, BILL OF RIGHTS, ARTICLE I, SECTION 27**  
**[Fundamental rights.]**

*Frequent recurrence to fundamental principles is essential to the security of individual rights and the **perpetuity of free government**.*

Take further notice that the government is to be regulated by the People as Trustees and Servants. It is your duty to carry out the wishes of the People who granted authority for you to handle the Peoples' business, and therefore, I am presenting fundamental law and instructions that you may observe and carry out the will of We the People.

**UTAH CONSTITUTION, BILL OF RIGHTS, ARTICLE I, SECTION I**  
**[Inherent and inalienable rights.]**

*All persons have the inherent and inalienable right to enjoy and defend their lives and liberties; to acquire, possess and protect property; to worship according to the dictates of their consciences; **to assemble peaceably, protest against wrongs, and petition for redress of grievances**; to communicate freely their thoughts and opinions, being responsible for the abuse of that right.*

Take further notice that the People have the power because the government was created by the People to carry out the will of the People. When the government is functioning in a way that goes against the People's will and authority, the People have the duty to correct the

government's behavior and lead them in ways consistent with the Constitution, and the Utah Constitution, to redress the Peoples' grievances.

I, a \_\_\_\_\_, as one of the People, am in full support of a full forensic audit of Utah's 2020 election cycle to include ALL RACES of cities, counties, and districts; both local and national.

This is a Constitutionally protected right of We The People. As such, I, a wo/man, require you to immediately do all things necessary for a complete forensic audit of all paper ballots, both in person and absentee, all machines, related software, routers, internet devices, and all other election related materials and systems within the use of Utah's elections.

The audit shall make provisions for ANYONE who wishes to view the audit, during the audit process, to do so. The results of the audit shall be made available to the public when completed.

Please advise me IN WRITTEN AFFIDAVIT FORM within ten (10) days from receipt hereof, if you believe the People DON'T have a right to alter or reform government if it is inadequate, in danger of maladministration, not benefiting the People, or negatively affecting the People's happiness.

Take further notice that as a Trustee you are bound by granted authority that exists in the Utah Constitution, and you have the duty to perform all obligations required of you as outlined in the Utah Constitution.

Your silence stands as consent to, and tacit approval of, the factual declarations herein being established as fact as a matter of law. It shall be considered that you agree the People have this right and that any attempt to block this right is a Trespass, Treason, and an attack done outside of the obligations granted to you through your oath of office.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.
